BUYER agrees to not use their Poodle for the breeding of Merle Poodles or Doodles of any Type. _____

BUYER agrees to only breed their Poodle to other Pure Breed UKC or AKC Registered Poodles. _____

BUYER agrees to not breed Poodle prior to 18 months for males and 24 months old for females. _____

BUYER agrees to not use their Poodle for back yard breeding and / or puppy mill breeding. _____

BUYER agrees to earn a title in one of the following action items: AKC / UKC or CKC Conformation, Dog sporting or Hunting trial. Please note: CGC title does not count.

If BUYER is found to have breached any part of the Full Registration Agreement then BUYER agrees to spay/neuter their poodle and must provide proof to BREEDER with in 30 days from breach, or return poodle to BREEDER at BUYER's expense. The BUYER is responsible for any and all of the BREEDER's legal, court and attorney cost/fees that are incurred from BUYERS breach of contract regarding to the Full Registration Agreement.

Purpose of Contract - Initial and Sign Below

All provisions in this contract are designed to safeguard the dog. The health and happiness of our poodles is our main concern. This document constitutes the entire agreement between the BREEDER and BUYER with respect to this sale. The signing of this contract indicates that the BUYER has read, agrees and understands all the conditions of this agreement. Should the BUYER choose to break any of the covenants of this Agreement, the Agreement will be considered null and void, and the BREEDER will have the right to repossess the PUPPY at the BUYER's expense. _____

Release of Ownership to BUYER

Upon execution of this contract, BUYER agrees to take full responsibility for their poodle of purchase including but not limited to the following: Overall wellbeing, nourishment, routine veterinary checkups, medical expenses, training and happiness. BUYER agrees to have your PUPPY seen by your vet within 3 days of purchase date, if a medical issue is found within the first 3 days from purchase date, BUYER may request a replacement puppy when available from same or future litter, upon the return of first puppy within 4 days of purchase date. After allotted time, BUYER excepts all health issues that may arise with PUPPY once they leave the care of the BREEDER.

Temperament

Watts Poodles strongly recommends that the BUYER attend obedience classes with PUPPY and provide proper socialization opportunities for the PUPPY. _____

Color & Markings

BREEDER does not guarantee puppies will stay the color they are at time of purchase, as many poodle colors tend to fade with age. BREEDER does not guarantee puppies that appear black at time of purchase will stay black, they may clear and/or fade to blue or silver. _____

Health Guarantee

I the BREEDER guarantee that the PUPPY is in perfect health, and was seen by our Veterinarian. De-worming and vaccinations have been completed as per schedule for the PUPPY's age. The BREEDER will provide the BUYER with a health record detailing the treatment the PUPPY has received under the BREEDER's care, and outlining future care the BREEDER feels is essential to the PUPPY's well-being. The BREEDER shall not be held responsible for the development of disqualifying faults, diseases, or disorders, which are due to including but not limited to, the BUYER's negligence, chance, or environmental conditions such as adult teeth, Cancer, Addison's, Digestive disorder, Bloat, Allergies, Parvo, dog flu, or distemper. The BUYER is responsible for all medical or legal costs for puppy, as of this day of purchase. The BUYER agrees that the BREEDER is not responsible for the BUYER'S actions including any medical care or procedures, legal issues, or anything effecting this puppy once it leaves the BREEDER'S possession. The BREEDER is not liable for any costs that result from BUYER'S actions or choices.

All genetic defects found must be verified in writing and dated by a licensed veterinarian who specializes in the defect that was diagnosed at BUYER's experience. BUYER must notify BREEDER by email (wattspoodles@gmail.com) with in 7 days and include the report from the licensed veterinarian along with contact info for the veterinarian.

*Not covered by two year health guarantee is hips and elbows do to diet, activity level and type of flooring puppy is raised on plays a large factor in how hips and elbows develop.

Microchipping Information

All Watts Poodles come microchipped. Watts Poodles shall be listed as Second contact. BUYER will be First contact. This is to ensure the safety of the dog.

Can't Keep you Poodle for any reason?

Watts Poodles will accept back at any time, at any age, any of their Poodles. BUYER agrees to pay any expenses involved in returning the Poodle Including up to \$300 for Health Check, Updated Vaccines and Spay & Neuter _____

Buyer agrees never to re-home, relinquish, trade, sell or euthanize any Watts Poodle without first consulting Watts Poodles. A written notice shall be submitted to the BREEDER via email, 30 days prior to such transaction.

BUYER agrees that Euthanasia of Poodle is not acceptable under any circumstances unless deemed necessary by veterinarian. BREEDER shall be notified prior to Euthanasia.

Grooming & Upkeep

BUYER understands the high maintenance grooming required for standard poodles. Standard Poodles need to be brushed daily in between grooming to prevent matting. Grooming should be completed every 4-6 weeks. Grooming should include: Bath, Blow-dry, Brushing, DE Matting, Hair Cut, Clipping of Nails, Cleaning of ears, Removing Ear Hair and Sanitary Shave. Shave Hair in between paws.
