PURPOSE OF CONTRACT

All provisions in this contract are designed to safeguard the dog. The health and happiness of our poodles is our main concern. This document constitutes the entire agreement between the STUD OWNER and BITCH OWNER with respect to this sale. The signing of this contract indicates that the BITCH OWNER has read, agrees and understands all the conditions of this agreement.

THE FOLLOWING CRITERIA MUST BE MET PRIOR TO BREEDING

MUST BE (2) YEARS OLD	Dog must be 2 years old at time of breeding or have had at least (3) Heat Cycles.
GENETIC DNA HEALTH TEST	Results of DNA test must be (NORMAL) - or - (CLEAR)
BRUCELLOSIS TEST	Must provide (NEGATIVE) result in Brucellosis test performed at least 2 weeks prior to breeding. Copy of test results required @ signing of this agreement.
HEALTH & CLEANLINESS	Dog must be in good overall health and appearance. Dog must be free of internal and external parasites (Fleas & Ticks & Worms) and shall be groomed prior to the breeding.

GENERAL TERMS OF AGREEMENT

- 1. The Stud service fee is in the amount of \$2,000.00 USD in form of cash, due at the time of breeding.
 - 1a. One puppy from the litter may be substituted in place of the Stud service fee at STUD OWNERS discretion.
 - 1b. BITCH OWNER agrees that STUD OWNER will have (1st Pick) of litter and puppy will come with full AKC / UKC registration paperwork. Please note: CO OWNERSHIP is not an option. Such puppy will be picked at 8 Weeks old.
 - 1c. A \$500 refundable deposit will be exchanged at time of breeding. The deposit will be returned once puppy is received.
 - 1d. There will be no contract or terms attached to the stud fee puppy.

- 2. The BITCH OWNER must warrant that BITCH has not been exposed to any other STUD prior to arrival of breeding and that BITCH will be protected from such exposure after her return home.
 - 2a. If BITCH OWNER is doing a multiple sire breeding, this must be agreed upon prior to breeding.
 - 2b. If doing a multiple sire breeding, BITCH OWNER will pay the above mentioned Stud Service fees.
 - 2c. If doing a multiple sire litter bitch owner will have the puppies DNA tested by AKC and release the results to the stud dog owner's to verify parentage of the puppies.

- 3. Should the pregnancy result in 3 or fewer viable puppies at birth, STUD OWNER agrees to provide additional Stud Services free of charge at the time of the following Heat cycle under the condition that the following criteria is met.
 - 3a. Puppies life has expired in less than 24 hours from time of birth.
 - 3b. STUD OWNER is notified in writing within 48 hours after loss of litter.
 - 3c. Expiration of puppies were not caused by Owners Negligence or lack of providing proper care.

- 4. The BITCH OWNER is fully responsible for all costs associated with whelping, after birth and raising puppies. STUD OWNER takes no responsibility or liability for BITCH or litter after time of breeding.

ALL PUPPIES SOLD TO NON-SHOW HOMES WILL BE PLACED ON LIMITED REGISTRATION WITH A SPAY/NEUTER CONTRACT

5. All puppies as a result from this breeding will not be sold, given, or auctioned to owners, nor to a pet shop, pet broker, pet wholesaler, laboratory, puppy mill, high volume breeder, or other agency. All show/breeding puppies resulting from this breeding must be sold with a contract stipulating that they must be at least two years of age prior to breeding, have obtained final hip, elbow, heart, and eye clearances from OFA and/or Penn Hip, and Genetic DNA Health Testing prior to breeding. Subsequent to the breeding, the BITCH OWNER agrees that at no time will this bitch be sold, traded, or given away to a third party while carrying puppies as a result of this breeding.

- 6. Stud dog owner will be provided with the AKC Litter registration number.

Terms of Agreement for Natural Cover

The bitch owner is responsible for providing transportation to and from the stud dog's residence at the appropriate time during her season and is responsible for all fees incurred during her stay with the stud dog owner. The Stud Service Fee covers up to (4) Ties between STUD and BITCH. Any injuries to STUD or BITCH resulting from the breeding is the BITCH OWNERS financial responsibility.

Notice of Liability

The owner of the bitch hereby releases Witney Watts or Watts Poodles, or any other members of the stud dog's household from any and all liabilities and/or damages such as illness, injury, or death to said bitch while in the possession of the stud dog owner. Under no circumstances is the stud dog owner responsible legally or financially for any illness/injury/death, which may occur during or after this breeding.

CONFLICT RESOLUTION

Mediation:

Stud dog owner and Bitch owner agree to mediate any dispute or claim arising between them out of this Contract, or any resulting transaction, before resorting to arbitration or court action. Mediation fees, if any, shall be provided by the BITCH OWNER. If, for any dispute or claim to which this paragraph applies, any party commences an action without first attempting to resolve the matter through mediation or refuses to mediate after a request has been made, then that party shall not be entitled to recover attorney fees, even if they would otherwise be available to that party in any such action.

Arbitration:

Stud dog owner and Bitch owner agree that any dispute or claim in law or equity arising between them out of this Contract, which is not settled through mediation, shall be decided by neutral, binding arbitration. The arbitrator shall be an attorney, unless the parties mutually agree to a different arbitrator. Judgment upon the award of the arbitrator may be entered in any court having jurisdiction, and the parties shall have the right to discovery in accordance with the State's civil code. With the exception stated in above in any action, proceeding, or arbitration between Stud dog owner and Bitch owner arising out of this Contract, the prevailing party shall be entitled to reasonable attorney fees, costs, and penalties from the BITCH OWNER.

This contract shall be deemed a legally binding contract and is under the jurisdiction of San Bernardino County in the State of California.
