BUYER agrees to not use their Kitten for back yard breeding and / or Kitten mill breeding. _____

If BUYER is found to have breached any part of the Full Registration Agreement then BUYER agrees to spay/neuter their Kitten and must provide proof to BREEDER with in 30 days from breach, or return Kitten to BREEDER at BUYER's expense. The BUYER is responsible for any and all of the BREEDER's legal, court and attorney cost/fees that are incurred from BUYERS breach of contract regarding to the Full Registration Agreement.

Purpose of Contract - Initial and Sign Below

All provisions in this contract are designed to safeguard the Sphynx. The health and happiness of our Sphynx Kittens is our main concern. This document constitutes the entire agreement between the BREEDER and BUYER with respect to this sale. The signing of this contract indicates that the BUYER has read, agrees and understands all the conditions of this agreement. Should the BUYER choose to break any of the covenants of this Agreement, the Agreement will be considered null and void, and the BREEDER will have the right to repossess the Kitten at the BUYER's expense. _____

Release of Ownership to BUYER

Upon execution of this contract, BUYER agrees to take full responsibility for their Kitten of purchase including but not limited to the following: Overall wellbeing, nourishment, routine veterinary checkups, medical expenses, training and happiness. BUYER agrees to have your Kitten seen by your vet within 3 days of purchase date, if a medical issue is found within the first 3 days from purchase date, BUYER may request a replacement Kitten when available from same or future litter, upon the return of first Kitten within 4 days of purchase date. After allotted time, BUYER excepts all health issues that may arise with Kitten once they leave the care of the BREEDER.

Color & Markings

BREEDER does not guarantee Kittens markings will stay the color they are at time of purchase, as many spots and markings /colors tend to change with age. _____

We do not guarantee that the Sphynx will be completely naked. Some Sphynx tend to grow hair later on in life.

Health Guarantee

I the BREEDER guarantee that the Kitten is in perfect health, and was seen by our Veterinarian. De-worming and vaccinations have been completed as per schedule for the Kittens's age. The BREEDER will provide the BUYER with a health record detailing the treatment the Kitten has received under the BREEDER's care, and outlining future care the BREEDER feels is essential to the Kittens's well-being. The BREEDER shall not be held responsible for the development of disqualifying faults, diseases, Contractable Viruses, or disorders, which are due to including but not limited to, the BUYER's negligence, chance, or environmental conditions such as adult teeth, Cancer, Digestive disorder, Allergies, Parvo, Distemper, Feline Corona Virus. The BUYER is responsible for all medical or legal costs for Kitten, as of this day of purchase. The BUYER agrees that the BREEDER is not responsible for the BUYER'S actions including any medical care or procedures, legal issues, or anything effecting this Kitten once it leaves the BREEDER'S possession. The BREEDER is not liable for any costs that result from BUYER'S actions or choices.

1 Year Genetic Health Guarantee

BREEDER Provides a 1 Year Genetic Health Guarantee that expires on Kittens 1st Birthday, that it will not develop the following conditions.

All genetic defects found must be verified in writing and dated by a licensed veterinarian who specializes in the defect that was diagnosed at BUYER's expense. BUYER must notify BREEDER by email (wickedlyenchantedsphynx@gmail.com) with in 7 days and include the report from the licensed veterinarian along with contact info for the veterinarian.

*Not covered by one year health guarantee is FIV, FELV, Feline Corona Virus.

Note: Species Appropriate RAW Balanced Diet must be fed to ensure the health of the Sphynx Cat. Not Feeding a balanced raw diet, will Exempt the Genetic Health Guarantee. Other exemptions include letting the cat outdoors, as they may contract disease.

Microchipping Information

All Spynx Kittens come microchipped. Wickedly Enchanted Sphynx shall be listed as Second contact. BUYER will be First contact. This is to ensure the safety of the cat.

Can't Keep you sphynx for any reason?

Wickedly Enchanted Sphynx has entered into this agreement with the buyer. If the buyer at any time for any reason can't keep the Sphynx, the buyer shall contact breeder and return the sphynx so it can be properly cared for and placed under a new agreement with a new family. This is to ensure the safety of our animals and confirm they do not end up in shelters.

Buyer agrees never to re-home, relinquish, trade, sell or euthanize any Sphynx without first consulting Wickedly Enchanted Sphynx Cattery. A written notice shall be submitted to the BREEDER via email, 30 days prior to such transaction. (wickedlyenchantedsphynx@gmail.com)_____

BUYER agrees that Euthanasia of the Sphynx is not acceptable under any circumstances unless deemed necessary by veterinarian. BREEDER shall be notified prior to Euthanasia.

Diet

BUYER understands that due to the nature of the Sphynx, they do best when fed a Raw Balanced Diet. It is highly recommended to keep your Sphynx on a Raw diet for its lifespan, however after 1 year old, you are welcome to feed any canned type food. Please note: Dry Kibble is never recommended, especially for male cats as it can cause crystals in their urine. Sphynx will be healthier, and have more longevity with a Raw diet. They will also have less oily skin which can occur with dry and canned food. All Kittens will come home already accustomed to a raw diet.
